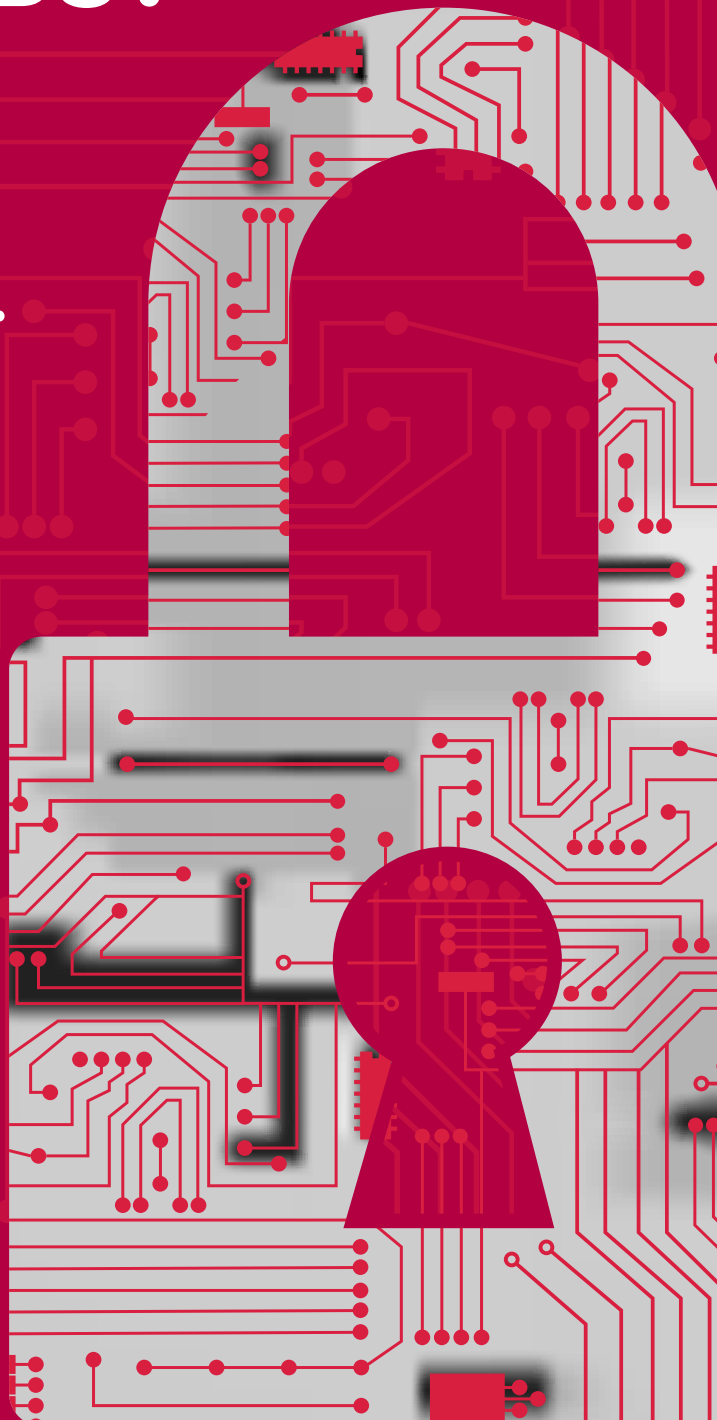

GDPR. Protect your business

The threat of cyber-attacks from Ransomware and Malware on businesses is real.

Now that GDPR (General Data Protection Regulation) is also in force it's even more important than ever that businesses implement the right level of network security and protect their own and customer data.

Many businesses mistakenly think that GDPR does not apply to them, while others are ignoring it and hoping it will go away. This is not the case - as all businesses need to comply.

The regulation replaced the data protection laws of individual countries helping to clarify and consolidate these laws into one. With these changes comes the requirement for more stringent business network security.



What is GDPR?

GDPR replaced the Data Protection Directive 95/46/ec and sets out minimum standards for the protection of EU Citizens' personal data and the free movement of data within the EU.

Companies have a legal obligation to be compliant. The regulations will apply to each member of the European Union and post Brexit UK. The regulation also extends the jurisdiction to all companies that process personal data of persons residing in the EU regardless of the geographical location of the business or the place where the data is handled or processed.

Breaching the regulation could lead to significant financial penalties and undoubtedly wider implications for the business as client's and customer's trust is tested.

If a business is found not to comply with GDPR and suffers a data breach, they could risk fines up to €20m or up to 4% of their total annual turnover whichever is greater.

Added to this, if there's a data breach or data is mishandled, individuals have the right to seek compensation for both minor and major breaches of the regulation.

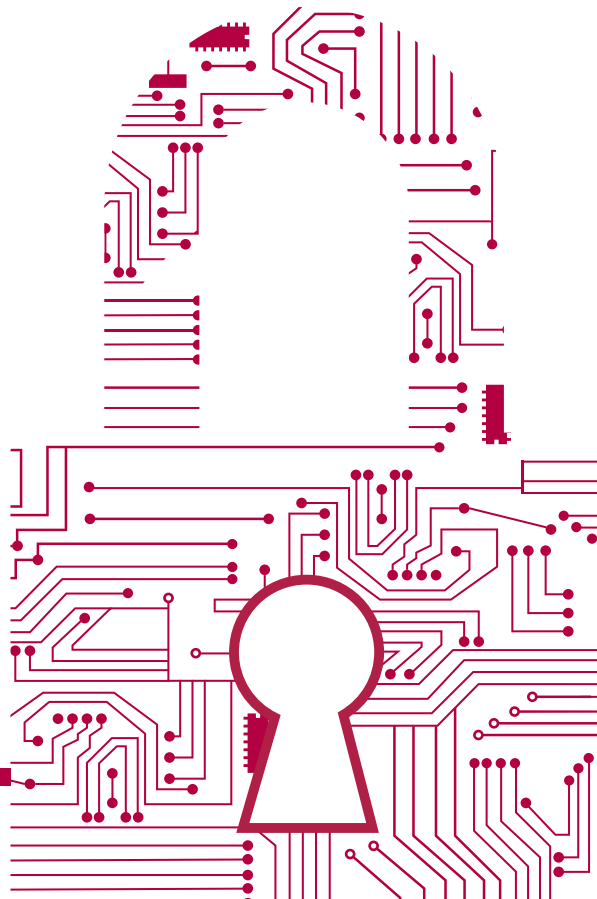
Article 32 specifically addresses the requirement for businesses to provide robust data security that enable secure access and secure processing of data. It states:

[Businesses must have] ...a process for regularly testing, assessing and evaluating the effectiveness of technical and organizational measures for ensuring the security of the processing.

It's imperative businesses implement a high standard of network security to be compliant with GDPR. With the increasingly frequent and sophisticated cyber attacks on networks and computers around the world, it's vital that all businesses take GDPR seriously.

Securing your Data

Businesses must have systems in place to secure their own and customer data they store. This may have been a low-level priority in the past, but with GDPR in force and the increasing threat from cyber criminals, they now have no choice but to take network security seriously.

Data breaches must be reported to data protection authorities and affected individuals within 24-hours. Even a small breach could be enough to shut a business down, whether it is from the fines or the impact on their reputation.

The regulation specifies that there must be appropriate protection from accidental or unlawful destruction, loss or alteration of personal data. Inadequate security and poor monitoring is not an option.

To be compliant businesses must put in place governance measures that include detailed documentation, registration and evaluation of security risks.

Business must employ data encryption and powerful real-time data protection measures that use innovate and constantly updated network security technology.

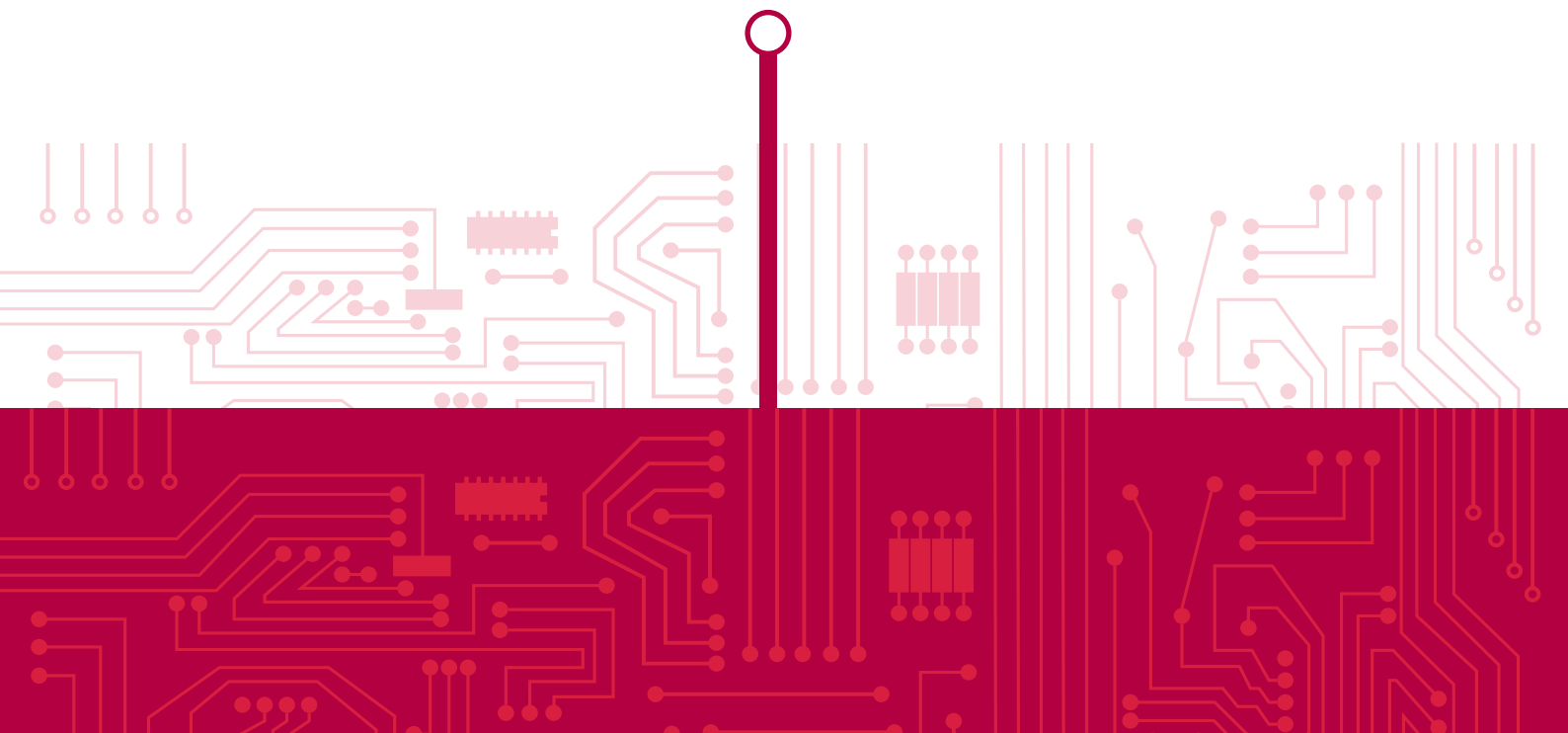

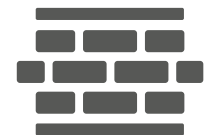

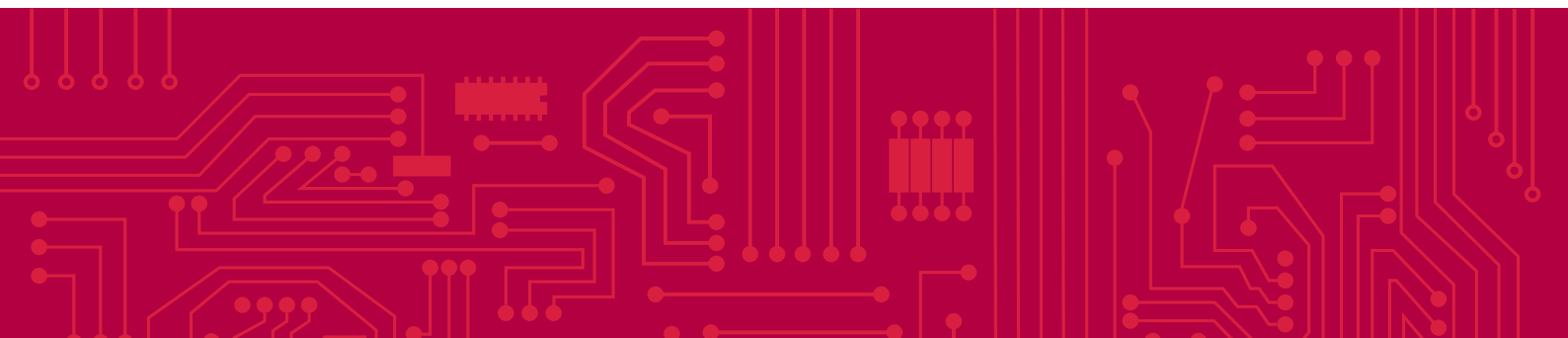
